




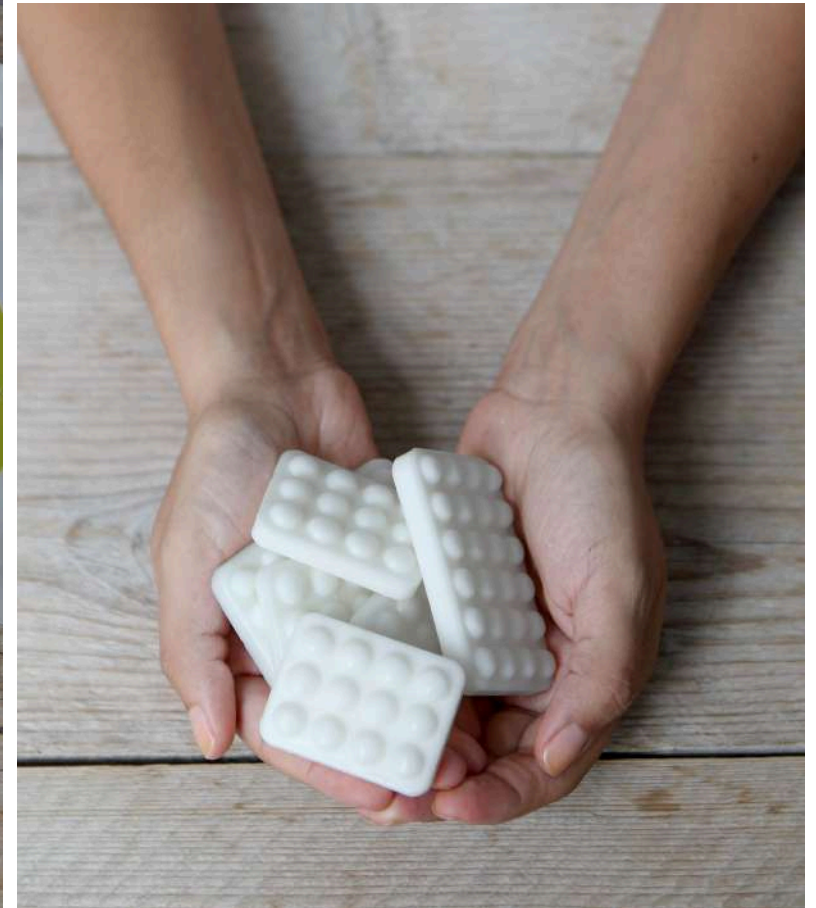

Anyah chooses to reduce the environmental impact throughout its life cycle, from the extraction of raw material through to production, use and disposal.

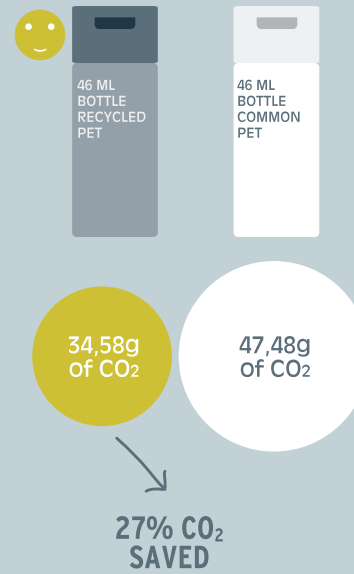
On each product we have specified the LCA results, which indicate the environmental impact throughout the entire life cycle.

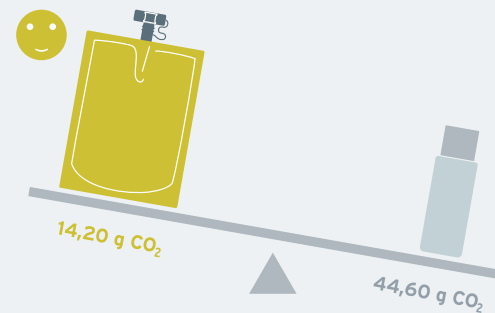

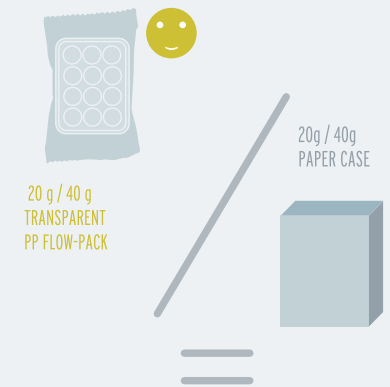

# YOUR TASTE OF NATURE: COSMETIC OVERVIEW

Anyah is a collection designed to combine the well-being of a person by meeting the most demanding needs and protection of the environment. The marriage of these two thoughts generates a very high quality Spa line of which many products are certified ECOLabel. Ecolabel is one of the most recognised European certification. Over time its regulations have become narrower in favour of even less environmental impact and therefore our formulations have been created using quality raw materials with reduced environmental impact and packaging that has been studied to evaluate its environmental impact throughout its lifecycle.



## EFFICACY TESTS

Many of my cosmetics formulations are supported by efficacy tests. Here is a detailed explanation:



### CONDITIONING SHAMPOO

From microscope visual analysis, hair samples treated with this cosmetic are better in structure and aspect, compared to non-treated hair samples.

*Lab test panel of hair samples treated with conditioning shampoo for 6 times consecutively.*



### AFTER SUN CREAM

This cosmetic has a restitutive effect, an Independent Lab tests panel of 20 people for 6 hours previously exposed to UV rays tested our cosmetic; was observed a significant reduction of skin evaporation (-8,8%) after 60 minutes, this effect is maintained also after 6 hours (-11,2%); a colorimetric analysis confirmed the restitutive effect, was observed in fact a reduction of redness in the area treated with the cosmetic after 6 hours.
